Impact Report 2024



We're very proud to have recertified as a B Corp for the third time, having first qualified in 2018. Going through this process is a great time to reflect on where we have come from, our core values, beliefs, but also to look at our ambitions and what we need to do to deliver on our mission.

We were founded in 1989, one of a few environmental consultancies at that time, with visionary leaders wanting to build a sustainable future. With a focus on making a positive impact on the planet, ensuring an enjoyable and supportive workplace and through working on groundbreaking projects, with innovative clients, the foundations were set for a business that cared; about the climate, society and it's people.

Over the last three decades, we've built on this vision. Adapting to the changing society, politics and policies, pandemics, science, technology, client requirements, etc. we've developed a company we are proud of, one that continues to make an impact.

2020 to 2030 was always going to be a critical decade for decarbonisation - and last year was about reviewing where our clients are at against their key interim milestones and looking at how to drive implementation harder and faster.

As we proceed we have ambitious plans to increase our impact, by innovating our existing services, expanding our sector reach, launching our new software product My Verco, working with BIP's sustainability centre of excellence, and ensuring our team continue to be at the heart of the business.



Our products and services deliver our mission

Report for zero uses cutting edge technology to track, verify and report on net zero progress and ensures our clients comply with legislation and meet their reporting requirements.





Factories, industry and retail

We support our clients by completing net zero studies, developing investment scenarios, supporting compliance, completing emissions assessments, supporting with CDP disclosure, helping with concept design for decarbonisation projects, securing government funding, undertaking technical due diligence, and offering a range of other services.

Implementation

In 2024, we worked with clients as they moved from goals and roadmaps to developing and implementing projects. As part of this, we developed investment scenarios for more than a billion pounds worth of capital for net zero projects. We provided concept designs and feasibility studies for typically hard to abate emissions, such as moving away from gas-fired CHP. We supported the funding applications for transformation technology such as geothermal and high temperature heat pumps.







Energy efficiency and decarbonisation in brewing

For over a decade, Verco has partnered with some of the world's largest brewing companies, helping them develop actionable energy efficiency and decarbonisation plans. Our unique combination of expertise in brewing processes, energy and water efficiency, and a deep understanding of decarbonisation technologies sets us apart.

In 2024 we conducted detailed assessments in more than 11 countries across 5 continents, covering breweries responsible for approximately a third of the world's beer production with a combined consumption of more than 1,800 GWh. On average, we have identified energy reduction opportunities of 35%. For example, we helped one of the world's largest breweries in Central America achieve a 20% improvement in energy efficiency within six months of our study. Another major brewery saw a 7.5% improvement just two months after our support.

Commercial Real Estate

In 2024, we completed environmental reports on over 3,200 assets with a floor area of around 60 million m². We supported clients with GRESB submissions, achieving over 50 stars. We also provided strategic and net zero advice to a range of real estate professionals, including fund managers and housebuilders.

National Buildings Database

Verco is pleased to be supporting Department for Energy Security and Net Zero (DESNZ), UCL and GC Insight with the creation of the National Buildings Database (NBD). The completed database will be used for research into energy use and carbon emissions, which can inform government strategy and policy.

In 2024, Verco supported the project through site-based audits and digital twin modelling, covering 72 sites. Commissioned by DESNZ, the purpose of the project was to develop a 3D model of the building stock in England, Wales and Scotland, including actual annual operational energy use.

Our work with DESNZ and UCL has proven our effectiveness at running large audit projects across many sites and producing industry-leading, high-quality data on a time-constrained schedule.

Global real estate investment firms

We work with our clients on strategic insights, including GHG baselines and costed, CREEM aligned, asset-specific NZC pathways for funds, assets and operation and 'whole life carbon'. We deliver consistent and scalable identification of interventions across geographies, funds and assets. We also support with fund and asset management engagement and output briefings.

Fund strategy

As strategic and technical advisor to a large pension fund, we supported their net zero and ESG strategies by creating offsetting and investor strategic goals, designing an operating mechanism to support the deployment of funds aligned with net zero principles and assed ESG, climate impact risk and UN SDGs.

As well as the above, we were shortlisted for the Global Sustainability and ESG Award in the Sustainable Consultancy category, and Consultancy of the Year in the UK Green Business Awards. We hosted seven Verco webinars on a range of topics from assurance to CSRD, and published articles with Property Week, The Grocer, Edie and Property EU. We were also a signatory on a letter coordinated by the UK Business Group Alliance for Net Zero, calling on the UK Government for a new era of UK climate leadership.





MyVerco, Verco's software platform that brings all of an organisation's net zero actions together, was launched in 2024, combining our decades of sustainability insight and data knowledge.

Despite having all of the data, many businesses are only making strategic changes to their net zero plans on an annual basis, and this makes it difficult to navigate the daily complexity of a decarbonisation pathway. Balancing carbon savings with technical and financial considerations in an ever-changing landscape can make it difficult to confidently commit to a set of preferred projects. That's why we developed MyVerco, which links on-the-ground actions to decarbonisation goals so that stakeholders across our clients' organisations can collaborate on their carbon reduction efforts in real-time.

The platform provides a real-time view of our customers' pathway, as well as reliable forecasts. It is also a single source of truth and can adapt to different business needs.

Verco has always had a clear vision focused on creating a sustainable future. This has evolved into our current mission, maintaining a focus on social and environmental considerations with responsibility for delivering stakeholder engagement and transparency. This has meant strong governance structures, ethical practices and clear reporting resulting in Verco receiving a very high B Corp score for this area and being classed as Best in World in 2022 for Governance and Workers.

With ISO9001, 27001 and 140001 we ensure we are working to best practice and as such are audited to these standards as well as financial auditing.

Since our last report, Verco has conducted anti-corruption training for all employees, launched a new code of ethics, maintained our considerate contractor status and achieved an enhanced score following our B Corp recertification.

Going forward we will continue to strengthen our B Corp score and focus on improving our Carbon Reduction Plan.

Verco has been monitoring and updating it's carbon footprint for over 10 years, with the full value change footprint including Scope 3 for over 5 years. We re-benchmarked in 2022 following significant changes from Covid.

In 2024, we moved two of our offices; Bath and London. Moving into a city location with better transport links and a more sustainable office location has seen a significant reduction in travel for our Bath office, as identified in our annual commuter survey. This, along with moving to a shared office location with BIP and Riskcare, to a BREEAM 'excellent' rated building, saw a drop in our energy and purchased heat, as well as a reduction in employee commuting, which should be more sizeable going into 2025.


Our annual footprint, however, did highlight an increase in worldwide travel for carbon reduction saving projects for our clients, following a gradual return to pre-Covid downturn levels.

Since 2016, we have averaged a 10.8% year on year reduction of Scope 1 & 2 emissions. Now we need to consider what's next. Our decarbonisation pathway is currently a focus for our Impact & Inclusion team.













Having built strong foundations to support and encourage people, facilitating growth through ethical practices that support the employee journey, we are constantly looking for ways to improve.

In 2024, we looked at benefits, policies, onboarding, and L&D planning. We see value in the team coming together in our offices, to learn from each other and socialise, but we've also been reviewing our hybrid and remote working policies. We offer flexible working, both formal and informal, which helps to facilitate a work-life balance.

Our recent focus has been on ensuring there are clear learning pathways, from Becoming a Consultant, to Consultant Mastery and Leadership Development training, with additional technical training requirements. We will be enhancing this further from 2025, with access to the Udemy business training portal.

We aim to continue aligning our company culture with our shared vision and purpose.

Verco's long-standing mission includes our ambition to 'develop a community of passionate and diverse professionals, committed to solving the complex challenges associated with climate change and resource efficiency'. Diversity and Inclusion is part of the Verco ethos, and is reflected in our achievements, such as the Great Place to Work award. We proactively champion creating a community where everyone feels welcome, supported, encouraged and accepted for the unique people they are, so we as a group can thrive.

Year on year we celebrate Pride, learn through Diversity Awareness Month, take part in B Corp month, and participate in environmental activities such as Plastic Free Month, Cycle to Work Week, and days volunteering on community projects.

For the last two years we have conducted a voluntary EDI survey to analyse our representation; we are healthy and represent a microcosm of the diverse make-up of the UK as captured in the 2023 EDI census.

However, we feel this area needs greater focus going forward, and in 2025 we are renaming our CSR team to 'Impact and Inclusion', conveying our commitment to social and environmental responsibility but also emphasising that it's our people that drive our impact. Looking to the future, we need to encourage more diversity in our engineering teams. We want everyone to know they're welcomed, included and valued.
